1. Information about the product	Extra virgin cold pressed rapeseed oil infused with black truffles. Perfect for frying, roasting, baking, dressing & marinating.

5. Hazard identification	Flammable liquid. Harmful if ingested and enters air ways. Harmful in contact with skin. Harmful in contact with eyes. Harmful to aquatic life with long lasting effects.
6. First aid measure	IF SWALLOWED REPORT TO DOCTOR IMMEDIATELY. Do not induce vomiting. In case of inhalation - Remove from exposure site to fresh air, keep at rest, and obtain medical attention. In case of skin contact – Remove/take off immediately all contaminated clothing. Wash with soap and water. In case of contact with eyes – Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.

10. Exposure controls/ personal protection	<p>Ensure good ventilation of the work situation.</p> <p>Normal work hygiene practices.</p> <p>Wear Mask and gloves when handling.</p>
11. Stability and reactivity	<p>The product is stable. Presents no significant reactivity hazard, by itself or in contact with water.</p> <p>Avoid contact with strong acids, alkalis or oxidising agents.</p> <p>Do not expose to direct heat.</p>
